- 1. Call to Order:** 9:04 AM; roll call.
- 2. Approval of agenda for March 18, 2021 meeting of the TADC** – approved unanimous.
- 3. Approval of minutes from December 17, 2020** – approved unanimous with edit of item 7 (i) Christ Arguello to Christy Arguello.
- 4. Gino Unzueta updates on the Taos Detention Information platform**
  - i. Special thanks to Angela MacDonald and Dominic Martinez for their assistance implementing the TDIS which was completed in October 2020;
  - ii. TDIS serves as a complement to the daily jail log that is emailed daily, includes inmates' photo, booking and release dates, case numbers, date of birth and address;

- 5. Genevieve Grant, IT Support Manager, AOC Judicial Information Division and Darla Goar, IT Business Analyst Senior, AOC: Presentation on the NM Dataexchange data sharing platform**
  - i. A quick overview of the NM Dataexchange data sharing platform was presented, this platform takes raw data and allows visualization of the data;
  - ii. The 2019 Crime Reduction Act provides the funds for this platform; in 2020 the pilot Phase I was implemented;
  - iii. Phase II will include transportation orders, and justice partners added data;
  - iv. The platform allows justice partners to use alone or share data;
  - v. Active warrants street map is uploaded through Odyssey.
- 6. County funding of GPS ankle monitors and work release permission**
  - i. Walter Vigil from HRDA, who holds the contract with Taos County for electronic monitoring stated he had sent an email regarding this matter last year;

- ii. There was not a representative from Taos County present at meeting to address this contract;
- iii. Judge Shannon stated that he will order work release of inmates from the TCADC if work release is not available while defendants are being electronically monitored (GPS) by the county, to maintain community safety while allowing inmates to maintain employment;
- iv. Aleksandar Kostich of the Public Defenders office stated he sees no meaningful distinction according to the contract;
- v. Leroy Vigil, Warden at TCADC, has asked for a meeting with the representatives from Taos County before work release from the detention center is implemented.

## **7. Covid-19 and the Courts**

- i. Jury trials have resumed in the Eighth Judicial District;
- ii. Covid-19 vaccinations were made available for all employees (that qualified and were not in quarantine), of the Public Defender's office, The District Attorney's office, The Eighth Judicial District and Magistrate Courts, and the Taos County Adult Detention Center, vaccinations were not mandatory;
- iii. One half of the employees of the Taos County Adult Detention Center employees have received the vaccine, there has been no discussion on offering the vaccine to detainees;
- iv. A meeting will be scheduled with the medical staff and Lieutenants of the TCADC regarding a plan to vaccinate detainees, HCAP will assist in researching the vaccine for detainees and Mr. Kostich of the Public Defender's office will educate defendants on the benefits of this vaccine.
