Agenda approved

Minutes from previous meeting, 12.17.21, not available for review/action

New Chair: Judge Shannon opened nominations for new chair. Zach Cordova nominated (J Shannon); seconded (L Herrera). Motion carried. Brief remarks by Chair Cordova, who then chaired remainder of meeting.

<u>Removal of non-participating members</u>: J Shannon explained difficulty in attaining quorum of 9 because of consistent non-participation by some members. Fewer voting members easier to attain quorum.

Removal Taos Municipal Court (moved/seconded/approved)

<u>Removal Taos Pueblo Tribal Court</u>: DA Montoya considers motion to remove premature, offers to contact new Tribal Judge Donald Gallegos. Moved to table (DA/seconded/approved)

Removal Taos E911: Discussion about Taos County chain of command; Bobby Lucero responsible for E911; his supervisor Jason Silva indicated his presence should indicate both E911 and Taos ADC are present. Brent Jaramillo agreed removal of E911 premature; will advise new ADC Warden of responsibility to attend CJCC. Moved to table (Brent/seconded/approved).

New Taos ADC Director Warden Danny Garcia: introduced, made brief remarks about background. Kostich inquired about in-person client meetings resuming. J Blankenhorn inquired about lifting quarantine requirement that inhibits detainees from attending in-person Court proceedings. Garcia awaiting advice/direction from NM Counties Assn. Will advise LOPD and Courts of CV procedure changes.

New Court CV Rules: CEO 8th District Karl Brooks briefed; items summarized on Agenda.

<u>Taos SIM Mapping Exercise</u>: AOC Scott Patterson briefed on Feb 24-25 Sequential Intercept Mapping exercise. Thanks to participants. AOC will provide full report and brief CJCC at May 6, 2022, meeting.
